Workshop

On 1-2 October 2009 the CIHEAM – Mediterranean Agronomic Institute of Bari successfully hosted in its headquarters the **Workshop on “E-Learning in the Mediterranean – Balkan Area”**.

The main aim of the event was to promote partnerships for the development of cooperation projects and the setting up of a database collecting initiatives and institutions operating in e-learning in the Mediterranean and Balkan countries. It was attended by a number of delegates who gave their contribution in order to establish a Distance Learning Working Group with a special focus on agriculture. The discussion led to the drawing up of a working document fixing three interrelated objectives to be achieved in the mid-term period, namely the preparation of a 3-year strategic plan, the realization of a well-built organizational structure and the development of suitable administrative and financial policies and procedures to create an effective and efficient network.



ONLINE EDUCA BERLIN

Online Educa Berlin is the world's largest e-learning conference for the corporate, education and public service sectors. This year's event took place on 2-4 December at the Hotel InterContinental in Berlin and was attended by 2078 delegates from 92 countries who discussed about the latest developments and trends in the field of technology-supported learning and training. Among the wide range of topics addressed, it is worthy remembering the great attention paid to the huge potential of e-learning in a period of economic downturn. As a matter of fact, the current economic crisis provides the e-learning community with a unique opportunity to show just how effective technology-supported learning can be in providing valuable learning opportunities in a cost-effective manner. Lifelong Learning Programme, Leonardo da Vinci sub-programme

The Leonardo da Vinci programme funds a wide range of actions, notably cross-border mobility initiatives, co-operation projects to develop and spread innovation and thematic networks. The potential beneficiaries are similarly wide – from trainees in initial vocational training, to people already in the labor market, as well as VET professionals and private or public organizations active in this field.

Seventh Framework Programme – Ideas - European Research Council (ERC)

The European Research Council (ERC) has a unique position in European research funding to support the best science and scholarship and the fundamental principle for all ERC activities is that of stimulating investigator-initiated frontier research across all fields of research. Awards will be made and grants operated according to simple procedures that maintain the focus on excellence, encourage initiative and combine flexibility with accountability. Two types of ERC grant are available at present:

1. The ERC Starting Independent Researcher Grants (ERC Starting Grants). The objective is to provide critical and adequate support to the independent careers of excellent researchers who are at the stage of starting or consolidating their own independent research;
2. The ERC Advanced Investigator Grants (ERC Advanced Grants). The objective is to encourage and support excellent, innovative investigator-initiated research projects;

The ERC actions are open to researchers of any nationality who would like to establish their research activity up in any Member State as well as any Associated country. The Principal Investigator can be of any age and nationality and he/she can reside in any country in the world at the time of the application.
