## **UnisulVirtual – Unisul's distance education campus: an Overview**

The UnisulVirtual campus is the unit specializing in distance education at the University of Southern Santa Catarina – UNISUL\*. The methodology adopted and the form of organization of distance education on the UnisulVirtual campus are in line with the concept of Virtual University where the pedagogic use of the technological digital communication resources allow the students to have permanent contact with their tutors, with their class colleagues, with the institutional administrative departments and remote access to the content and learning activities. The students are situated throughout the whole of the Brazilian territory and in other countries.

### **The methodology of the UnisulVirtual campus**

UnisulVirtual employs a teaching methodology which gives priority to the use of digital technologies for permanent contact between the distance students and their university teachers, allowing the students to study and clear up their doubts from any computer which is connected to the Internet. UnisulVirtual created the Virtual Learning Space tool as the main resource for pedagogical mediation between teachers and students. The students also receive printed teaching material, CD-ROMs and DVDs to do their reading and simulation activities which are compulsory to the programs.

## **EUROPEAN AND INTERNATIONAL CALL FOR PROPOSALS**

### **European Programmes**

Guide Association makes available websites links of the main European programmes and calls, which could be of possible interest for members institutions, universities or private and public bodies willing to establish useful partnerships for the development of global cooperation projects.

#### **Lifelong Learning Programme, Leonardo da Vinci sub-programme**

The Leonardo da Vinci programme funds a wide range of actions, notably cross-border mobility initiatives, co-operation projects to develop and spread innovation and thematic networks. The potential beneficiaries are similarly wide – from trainees in initial vocational training, to people already in the labor market, as well as VET professionals and private or public organizations active in this field. Leonardo da Vinci enables VET organizations to work with European partners, exchange best practices, increasing the expertise of their staff and respond to the teaching and learning needs of people. Leonardo da Vinci should increase placements in enterprises to 80,000 per year by the end of the programme.

Applicants must be established in one of the following countries: the 27 Member States of the European Union (as of 1 January 2007), the EFTA-EEA countries: Iceland, Liechtenstein, Norway and candidate countries: Turkey.

#### **Lifelong Learning Programme, Grundtvig sub-programme**

Grundtvig aims to provide adults with ways to improve their knowledge and skills. It not only covers learners in adult education, but also the teachers, trainers, education staff and facilities that provide these services. These include relevant associations, counseling organizations, information services, policy-making bodies and others involved in lifelong learning and adult education at local, regional and national levels, such as NGOs, enterprises, voluntary groups and research centers. Grundtvig should support the mobility of 7,000 individuals involved in adult education per year by 2013.

Applicants must be established in one of the following countries: the 27 Member States of the European Union (as of 1 January 2007), the EFTA-EEA countries: Iceland, Liechtenstein, Norway and candidate countries: Turkey.

### **Lifelong Learning Programme, Comenius sub-programme**

Comenius seeks to develop knowledge and understanding among young people and educational staff of the diversity of European cultures, languages and values. It aims at improving and increasing the mobility of pupils and educational staff in different Member States and is focused on enhancing partnerships between schools with at least three million pupils taking part in joint educational activities by 2010. Another goal of the sub-programme is that of encouraging language learning, innovative ICT-based content, services and better teaching techniques and practices. Comenius should involve at least three million pupils in joint educational activities, over the period of the programme.

Erasmus is the EU's flagship education and training programme, enabling two hundred thousand students to study and work abroad each year. It caters not only for students, but also for professors and business staff who want to teach abroad and for university staff who want to be trained abroad. In addition to mobility actions, the Programme supports higher education institutions to work together through intensive programmes, networks and multilateral projects. Erasmus should reach the total of three million individual participants in student mobility actions since the programme began.

### **Culture Programme**

The EU's Culture programme (2007-2013) has a budget of €400 million for projects and initiatives to celebrate Europe's cultural diversity and enhance our shared cultural heritage through the development of cross-border co-operation between cultural operators and institutions. The Culture programme aims to achieve three main objectives: to promote cross-border mobility of those working in the cultural sector, to encourage the transnational circulation of cultural and artistic output and to foster intercultural dialogue. For the achievement of these objectives, the programme supports three strands of activities: cultural actions, European-level cultural bodies and analysis and dissemination activities.

Applicants must be established in one of the following countries: the 27 Member States of the European Union, European Economic Area (EEA) countries (Iceland, Liechtenstein, Norway), countries candidate to EU membership (Croatia, Turkey and Former Yugoslav Republic of Macedonia) plus Serbia. The countries of the western Balkans (Albania, Bosnia-Herzegovina and Montenegro) could become eligible in the future, subject to the conclusion of a Memorandum of Understanding concerning the participation of each of those countries in the Programme. There are also some third countries which can participate to specific actions of the programme. They are: Armenia, Belarus, Egypt, Georgia, Jordan, Moldavia, Tunisia and Occupied Palestinian Territory.

### **PRO€INVEST Programme - Technical and financial support to organisations representing the ACP private sector**

PRO€ INVEST is a programme of the Group of ACP States and the European Commission for the promotion of investment and technology transfers in ACP countries. Its management has been entrusted to the Centre for the Development of Enterprise (CDE) under the supervision of EuropeAid Cooperation Office of the European Commission (EuropeAid). The programme was launched in 2002 and has a budget of 110 millions euros.

The Pro€Invest objective is to promote investment and technology flows to enterprises operating within key sectors in the ACP States. This will be achieved through a two dimensional approach: to support intermediary organisations and professional associations and to develop inter-enterprise partnerships. In order to address these issues, PRO€INVEST adopted a two-dimensional approach: Reinforce the capacity of ACP intermediary organisations who have a key role to play in the improvement of the investment environment and support identified key sectors by organising investment conferences.

### **MEDIA 2007 - EACEA/18/08 - Audiovisual festivals**

On 15th of November 2007 the European Parliament and the Council adopted a new programme to support the European audiovisual sector: MEDIA 2007. The budget will be €755 million over seven years (2007-13). The overall objectives of MEDIA 2007 are: - to preserve and enhance European cultural diversity and its cinematographic and audiovisual heritage, guarantee accessibility to this for Europeans and promote intercultural dialogue - to increase the circulation of European audiovisual works inside and outside the European Union - to strengthen the competitiveness of the European audiovisual sector in the framework of an open and competitive market.

The present notification is addressed to European organisations and to those registered in and controlled by nationals from the Member States of the European Union and countries of the European Economic Agreement participating in the MEDIA 2007 Programme (Iceland, Liechtenstein, Norway), Switzerland and Croatia.

### **TREN/SUB 02-2008 - Urban Mobility**

The European Commission intends to award grants to actions in support of the development of sustainable mobility policy for urban agglomerations. These actions should promote the objectives of sustainable urban mobility in line with the approaches set out in the Green Paper: more fluid and less polluted towns and cities, more intelligent and more accessible, and safer and more secure urban transport. The proposals to be selected should promote good practice, with a focus on one (or several) of the following five areas: - safe walking and/or cycling in towns and cities; - goods transport and logistics in towns and cities; - approximation of the systems of green areas in towns and cities; - interoperability of the information and payment systems of public and private modes of transport in towns and cities; - demand-responsive transport for passengers in towns and cities and the suburbs.

The European Commission has launched together with the US Department of Education a new joint call for proposals covering a series of actions grouped under the common title of "ATLANTIS". The general objectives are to promote mutual understanding between the peoples of the European Community and the United States of America including broader knowledge of their languages, cultures and institutions and to improve the quality of human resource development in both the European Community and the United States of America. ### **EU-CANADA Transatlantic Exchange Partnerships (TEP) Programme**

In the context of the European Union - Canada Framework for Co-operation in Higher

The main focus of activities must be on transatlantic rather than intra-European or intra-Canadian interactions. Submission of grant requests under this 2009 Call for Proposals is open to higher education institutions and to vocational education and training institutions.

### **ACP Science and Technology Programme**

The overall objective of the ACP Science and Technology Programme is to support ACP countries in formulating and implementing science and technology (S&T) policies that can lead to sustainable development and to poverty reduction through economic growth and progressive integration in the world economy. The Programme promotes interdisciplinary approaches to sustainable development along three main axes: - co-ordination and networking in applied research; - instruments for collaborative research; - management of research activities and reinforcement of research.

The programme is open to all 79 member states of the African, Caribbean and Pacific Group of States (ACP), the 27 member states of the European Union (EU), the 3 EU candidate countries, and the 3 member states of the European Free Trade Association (EFTA) that belong to the European Economic Area (EEA), it funds partnership projects to be selected through an open Call for Project Proposals.
