Two types of ERC grant are available at present:

- 1. The ERC Starting Independent Researcher Grants (ERC Starting Grants). The objective is to provide critical and adequate support to the independent careers of excellent researchers who are at the stage of starting or consolidating their own independent research;

The Europe for Citizens programme aims to bring people from different parts of Europe together in order to promote mutual understanding, a sense of ownership of the European Union and the emergence of a European identity to complement local and regional ones.

It funds and supports different kind of activities:

Action 1. Measure 1 – <u>Town twinning</u>: supports town twinning and involving large numbers of citizens directly.

Action 1. Measure 1.1 – <u>Town twinning citizens' meetings</u>: supports exchanges and gatherings of a wide range of citizens and citizens' groups from twinned towns.

Action 1. Measure 1.2 – <u>Thematic networks of twinned towns:</u> profiled networks allow cities, towns and villages to build common ground and to pool resources in order to get more closely involved in the policy-shaping process.

Action 1. Measure 2.1 – <u>Citizen's projects</u>: provide support for citizens' projects which aim to empower Europeans from different countries to come together around common issues.

Action 1. Measure 2.2 – <u>Support measures:</u> promotes the exchange of good practice and help pool experience.

Action 2. Measure 3 – <u>Support for projects initiated by civil society organisations:</u> these projects should address issues of European interest and focus on putting forward concrete solutions, through cross-border co-operation or coordination.

Action 4. <u>Active European remembrance:</u> by commemorating the victims of Nazism and Stalinism Europeans can draw lessons for the present and the future.

Seventh Framework Programme – People - Support for Training and Career Development of Researchers

This action aims to reinforce the international dimension of the career of European researchers by giving them the opportunity to be trained and acquire new knowledge.

The following types of actions are planned during FP7:

- Initial training of researchers to improve their skills and help them join established research teams. In parallel, complementary training will enhance their career prospects in both public and private sectors.
- Lifelong training and career development through individual fellowships and co-financing programmes at international, national and regional level.
- An international dimension to be addressed through international outgoing and incoming fellowships aiming to increase research talent outside Europe and fostering mutually beneficial research collaboration with researchers from outside Europe.
- Specific actions will be implemented to support the creation of a genuine European labour market for researchers, such as the removing of obstacles to mobility and enhancing their career perspectives.

Researchers must be nationals of a Member State or Associated country.
